### 2. Performance Cookies

- Help us analyze site performance and improve user experience.
  - Examples: Page load times, error tracking, and most visited pages.
3. **Functional Cookies**
- Enable enhanced functionality and personalization.
  - Examples: Remembering your language or region preferences.
  - Disabling these cookies may affect some features of the website.
4. **Marketing and Advertising Cookies**
- Used to deliver tailored advertisements based on your interests and browsing behavior.
  - May track interactions with advertisements and measure campaign performance.
  - Examples: Retargeting ads and social media integrations.
